There followed a prolonged discussion about the plot of land belonging to the Parish Council, currently being leased to the National Trust as car parking. The outcome of the discussion was an arrangement by a member from each of: Oxborough Parish Council, the Parochial Church Council and Hewar's Charities, to form a working group to explore the future use & financing of the plot of land whenever the lease with the National Trust terminates.
